A motion to suppress is an attempt by the defense in a criminal case to keep evidence out of court. It gets the "pretrial" label where procedural rules require that the defense bring the motion before the trial stage.If you are served with a motion to change support, you are the "respondent." You must appear and answer the motion by the date on the notice of hearing. You can appear and answer by either: 1) filing a written reply or motion and serving the moving party with that reply or motion; or 2) orally answering each allegation in the motion at the hearing.
